Please find attached the select list of Class VI of your JNV for processing admission of selected candidates and also to upload on the JNV website.

In this connection you are requested to note the following points for strict compliance:

1. The selected candidates can submit their willingness for admission through online submission which will be automatically communicated through email to JNV concerned immediately.
2. Principal can view the list of candidates with three portions.
 - Willingness submitted
 - Documents submitted
 - Admission Status
 - Admitted
 - Not admitted
 - Pending
 - Not Eligible
3. The entire admission process of main list of selected candidates is to be completed by 10.06.2019.


4. Points to be strictly adhered to during the process of class VI JNVST admission.

- (i) OBC candidates need not be insisted to submit category certificate. If certificate is not produced, the candidate can be considered as General. On any account admission to such OBC candidates shouldnot be denied since there is no reservation for OBC candidates.
- (ii) If any reserved category student is seleged under open unreserved quota, the candidate may be admitted, even if the candidate does not produce category certificate. However, such candidates are to be treated as general candidates, if relevant category certificate is not produced.
- (iii) The selected candidates are to be intimated by speed post along with a set of formats to be submitted at the time of admission. Proper follow up is to be ensured by JNV
- (iv) After one week, second and the final speed post intimation should be sent to candidates who have not reported for admission.
- (v) Report on information of admission process on day to day basis is to be submitted to RO through online by 2.30 p.m. every day so as to enable this office to send consolidated vacancy position to NVS Hqrs by 3.00 p.m. every day in the following format.

JNV	Total Selected	Cumulative admitted right from beginning

Please note that the target of NVS for 2019-20 is to ensure Zero Vacancy in Class VI by 15.7.2019 including release of wait lists,if any. Hence Principals of JNVs are requested to ensure that there exists no vacancy in class VI after 15.7.2019.
